# 1. CALL TO ORDER @ 9:15 AM

The President reviews the agenda, 11 active directors, 6 is required for a quorum

#### 2. APPROVAL OF AGENDA:

Moved by Denise, Seconded by Norma, all in favour, motion carries

# 3. APPROVAL OF MINUTES:

Moved by Norma to approve the minutes of the last meeting of Aug 12, 2013 with the suggested changes, seconded by Lynda, all in favour, Motion carries.

#### 4. CORRESPONDENCE:

- The BCQHA Executive sent two Northern BC directors letters to inform them that they
  were no longer eligible to stand as directors on the BCQHA BOD as per BCQHA bylaws.
- Letter of resignation and relinquishment of membership was received from a South Central representative and accepted by the BOD

#### 5. FINANCIAL REPORTS:

Moved by Lynne and seconded by Lynda to move the \$447.95 from 4-H to the Youth fund, all in favour, motion carries

#### 6. OLD BUSINESS:

- a. Trophy Placement In contact with Langley Farm Museum members ongoing
- b. Memory Books Picking a date in November 2013 to get together to make records of the Trophy. Denise and Haidee to complete cataloguing.
- c. Fund Raising –an electronics raffle for a bursary for youth pursuing further education. A maximum of \$1000 to be spent on three prizes. update and action plan. Draw date Oct 26, 2014. Denise will start the process of completing the application.
- d. CQHA Grant Application 2013 Follow Up. Sponsorship for HCBC \$500. Booth expense \$500, Regional Championships. Still have about \$300 to spend to enhance to booth. Gordie will look into AQHA DVD's and Haidee will investigate a new banner.

Norma moves, seconded by Gayle to reduce the number of required shows to 4 to qualify for the Novice Championships. Motion carries with Lynne Carter opposed.

- i. Year End Awards update re point keepers, they are ahead of schedule this year. Confirmed approach and the budget is \$1400. Gayle will Chair, Lynda agrees to help with certificates
- j. Web site contract review Reviewed original contract proposal. Working relationship with current provider is going well. BOD is extremely happy with the web-site. need "How to get involved" tab, need more members getting advertisers

Denise moves, Lynda seconds that we continue with VP Graphix as our website provider, all in favour, motion carries.

- k. Logo'd prizes to recognize QH's competing at non AQHA events and open shows BCQHA provides annual recognition for highest placing registered AQHA horse in your association. This is at no cost to your club. You simply apply to BCQHA to receive the award. Gordie will produce an application form to provide to the website.
- I. Mailing address The Board of Directors feels the current BCQHA mailing arrangements work for BCQHA and feel there is no need to make any changes to the address.

Norma moves, Denise seconded to continue with the current postal address and arrangement, all in favour, motion carries

m. Waiver release - The BCQHA BOD asks that the Zones replace their Waiver and Release and all previous versions with the current version to be found on the BCQHA website. Lynda to complete the change to add "and it's zones" and ensure release of photos for promotional purposes.

  - Norma moves, seconded by Lynda that the Reps bring forward to the R1AQHA board that BCQHA has donated \$16,000 to the Region. \$8400 of which is over and above the cost to bring the Regional Championships into Canada. BCQHA donated \$8,000 to the Region in 2012 prior to the first Regional in Wash. State. BCQHA would like to work together with the R1 affiliates for a common goal with R1AQHA in it's entirety. Failing that outcome, BCQHA requests our excess donation of \$8400 be returned prior to the dissolution of R1AQHA and an equal division of the remainder of the R1AQHA funds, including all physical assets ie prizes, amongst the five affiliates. Motion carries.

a. Take Aim 2014 - Program has changed and isn't currently relevant to BCQHA. New annual planning from this point forward will be called Strategic planning.

# 1. Membership - \$250

25,282 Registered AQHA Horses, with 8,717 owners and about 2,500 are current AQHA members in BC.

#### Goals:

- Initiative to increase membership
- Grow membership involvement
- Review and possible enhance the benefits of membership

#### Action:

- Update policy to include "Memberships processed in the 4th quarter will be processed as the following year"
- Need Zones to have a member responsible for "Membership" in their zone.
   Promoting and collecting membership to forward to the BCQHA membership secretary.
- Members purchasing their membership are entered into a draw for BCQHA Logo'd items at the Horseman's Bazaar in 2014
- Provide membership benefits
- Field Battle of the Breeds Team QH at the PNE
- No increase in membership fees for 2014

- BCQHA BOD wants to encourage social get together, ie barn dances, Halloween parties, tail gate parties at trail rides
- Opportunity to contact AQHA members through AQHA, Haidee to investigate cost
- Encourage zones to have a Recreation/ social position
- Form committee to investigate approach to reach AQHA owners. Lynne, Denise, Haidee

<u>Desired Outcome:</u> Connecting with more AQHA horse owners and providing diverse activities to growing membership

#### 2. Youth

Monies available to reach these goals about \$4,500 \$1000 Stallion draw \$447.95 left from 4-H event approx. \$3000 in youth savings acct

#### Goals:

- Increase Youth membership
- Develop future leaders

#### Action Item:

- Support participation for Regional Youth Seminar
- Support participation for AQHA YES Conference
- Draw fundraising to go towards Youth Bursary
- Include the above items in the AQHA outreach
- Encourage zones to name a youth coordinator

<u>Desired Outcome:</u> The youth come together, attract friends to the assoc. and develop relationships. The Youth organize, have fun together and become familiar with AQHA programs, benefits and services.

# 3. Recreation - \$500

#### Goals:

- To reach more AQHA owners that participate in Recreational Riding
- To grow our membership amongst recreational riders.

#### Action Items:

- To hold at least one AQHA Trail Challenge in the Province
- To hold at least one AQHA Trail Ride in the Province
- To develop our recreation committee to involve members from each zone
- Promote our recreational riding awards program

Include in AQHA Outreach

Desired Outcome: the Association attracts more non-showing members

# 4. Education \$1,000

Goal:

• Increase education opportunities for all AQHA owners and potential AQHA Owners

Action Items:

- Promote horsemanship education for the novice through advanced clinics
- Provide education on equine health and welfare veterinary clinics/seminars
- Utilize the website to highlight educational topics
- Encourage show committees to organize educational opportunities

<u>Desired Outcome</u>: Members see value in maintaining their membership, skills and education are advanced

#### 5. Show - \$500

Goal:

Increase participation at shows

Action items:

- Encourage show committees to include educational opportunities at shows
- Encourage show committees to include walk/trot or small fry classes
- Include "Ride the Rail" class.
- Look at all avenues to reduce show expenses to competitors.
- Encourage show committees to explore opportunities to partner with alliance groups
- Free class certificates for Open/Alliance show year end highpoint recognition

Desired Outcome: Show attendance increases.

# 6. Board Development - \$500

Goal:

Increase participation at the BOD meetings and on the committees

Action items

- Zones need to ensure at least one of the representatives to the BCQHA BOD also be on the BOD in their Zone
- Inform Zones of the expectation that Reps to the BC BOD attend meetings.

- Develop a summary of director responsibilities
- Update BCQHA directors policy
- Provide education to board members to increase productivity
- Reach out to general membership to be active on committees
- BCQHA participate in an effort to contact NBC members to participate at the Zone and BC board level.

### **Desired Outcomes:**

- Zones would appoint only representatives to the BCQHA BOD who are willing and able to participate in meetings
- Representatives would be educated on the policy and procedure of the Association
